SUPERINTENDENT'S REPORT

Preparations for BHS Presents, to be held on April 17-18 are underway. They also reported on events in the Art, Science, and Music Departments. Mr. Rozakis, Superintendent, announced that we will be celebrating the achievements of some of our students and teachers. The Board of Education recognized Christian Martino and Patrick Roche for being selected to perform with the SCMEA All-County Percussion Ensemble and Sachi Onishi, Lauren Ragen, Sophia Sherman, Emma Schubart and Ethan Schubart for being selected to perform at the Long Island String Festival. Ms. Claire Birone, science teacher, has been selected and recognized as a top educator in the State with her acceptance into the New York State Master Teacher program. Ms. Donna Hendrickson, grade school teacher, earned the Suffolk County PTA Ted Brigham Teacher of the Year. Ms. Judith Procaccini, science teacher, was commended for coming to the aid of a student in her biology class by successfully performing the Heimlich maneuver. # MANDATORY STATE EDUCATION DEPARTMENT FIELD TESTING

11. MANDATORY STATE EDUCATION DEPARTMENT FIELD TESTING: WHEREAS, mandatory New York State assessment tests in ELA and math are given to New York students in grades 3 through 8 during April of each school year which is the beginning of the fourth quarter of the school year. The Babylon Union Free School District Board of Education believes this timing is dictated by the needs of the State Education Department teachers' and principals' accountability system, known as APPR; WHEREAS, the Board of Education believes the quality of instruction of all students in grades 3-8 is lowered by mandatory testing practices of the State Education Department resulting in the reduction of students' learning opportunities; WHEREAS, these

mandatory tests are developed, in part, through the administration of additional "field tests" used by testing companies to develop appropriate questions for future tests; WHEREAS, the Board of Education believes the testing companies realize a commercial profit by using children and taxpayer resources to advance their business plans; WHEREAS, in the past, a district's participation in these "field tests" was on a voluntary basis; WHEREAS, the State Education Department has proposed amending certain Regulations of the Commissioner of Education such that New York school districts would be required to administer the "field tests". The Board of Education believes this will result in the use of more instructional time for the purpose of advancing a mandatory testing system organized and based, in part, on APPR, not on the basis of what is best for children; WHEREAS, the Regents are considering the proposal of the State Education Department to make the administration of these "field tests" mandatory; WHEREAS, the Board of Education believes additional mandatory testing will force children and districts to, in effect, subsidize the profit-making work of testing companies thus using public resources and private families for the purpose of advancing a private business plan. NOW THEREFORE, BE IT RESOLVED, the Babylon Board of Education disagrees strongly with any additional mandatory testing and urges the Regents to reject the State Education Department's proposal to make "field tests" mandatory and to reconsider its approach to assessing student learning and teacher and/or principal effectiveness. The Board of Education believes that a decision to increase mandatory testing would hurt children and abuse the public trust by subsidizing private enterprise without public discussion.

Dr. Daly updated the Board on his meeting with the PTA and concerned parents regarding the transportation program and presented the Board with action items to consider. The Board will schedule a special meeting to review the transportation program and post the meeting on the district website. Mr. Rozakis reminded the Board that a decision regarding changing the afterschool childcare program from SCOPE to YMCA will need to be made in a timely manner on whether to renew the existing afterschool program or move instead to contract with the YMCA. The Board would like to schedule a site visit for the YMCA.
