SUPERINTENDENT'S REPORT

Student Council Delegates reported that officers have been appointed for the 2015-2016 school year and preparations are already underway for the fall. The Babylon Buddies Got Talent show is scheduled for Friday, June 5 at 6:00 p.m. Students from the Interact Club are in the process of completing their Bonnie Boxes project. They also reported on events in the Practical Arts Department. The Board of Education recognized the Senior High School's Symphonic Winds and Jazz Band who performed at the Heritage Music Festival in Williamsburg, VA and art students who were recipients of an Award of Excellence or Honorable Mention at the Babylon 5th Annual Arts Festival. The Board of Education recognized Mohankumar Chintarlapalli as the Valedictorian and Ronald Pashen as the Salutatorian of the graduating Class of 2015.
