**CALL TO ORDER** 

The meeting was called to order at 6:30 p.m. by C. Dell'Erba, President. A motion to enter executive session by D. Noesi and seconded by D. Montalto, for the purpose of discussing the employment history of particular individuals and advice from counsel was made. (7-0) Public session resumed at 7:30 p.m. at which time C. Dell'Erba, President, led the assemblage in the Pledge of Allegiance.

SUPERINTENDENT'S REPORT

Mr. Conboy reported that Brady and Maeve, students from the Jr./Sr. High School, are going to fill us in on various exciting things that are happening at the Jr./Sr. High School. Student Delegates, Brady and Maeve, reported the following:

**Senior High Student Council Events**: Student Council has put together a fantastic opportunity to showcase the many talented students we have at BHS. BHS Presents is scheduled for Thursday, March 30th at 7pm. All are welcome.

Some spring fun events are also in the works. Details to follow.

Fine Arts: March is Youth Art Month. The art department is busy with lots of activities. We participated in the SEL day on Friday and had the senior high students create a tape mural and a painted mural. The junior high created drip drawings that will be put together into a mural. 24 of our kindergarteners through 8th graders have their artwork in the SCALA children's show at Babylon old Town Hall this month. 10 of our K to 12th grade students will have their artwork displayed in the NYSATA virtual legislative show this month too. During art week this week, students will learn about different artists during morning announcements and have an art challenge each day. There will be a mindful weave project available for all to participate in. And finally, today, all of the art students participated in a "Make mindful art Monday" and created small pieces of artwork that will be put together into one large mural.

**Math Department**: The Math Department will be celebrating Pi Day on March 14th (3/14) in all math classes. Teachers have various activities planned throughout the day. To tie everything in with

SEL/Mental Awareness Month, students will be creating a "Pi Chain of Kindness." Students will choose a kindness quote that they will write on a strip of colored paper, and then the quotes will be linked into a paper chain following the digits of Pi. The day will culminate in a contest to see who can memorize the digits of Pi out the farthest.

World Languages: This week was fantastic, filled with Languages for a Peaceful World!

We began the week with a Landmark Scavenger Hunt where world landmarks were hidden throughout the building and students brought them to a World Language Advisor for a prize!

Tuesday was very special as a group of HS students accompanied by Mrs. Anderson, Ms. Caldwell and Mr. Cropsey traveled to the Elementary and Grade Schools to spread World Language Week cheer by way of activities in multiple languages centered around a book called How do you say Peace? At the HS, students completed a history webquest for prizes!

Wednesday featured a music battle called Musique Miércoles during which WL teachers played Spanish & French music videos and the student body voted with the winner being "La Gozadera" by Gente de Zona & Marc Anthony.

After school on Wednesday, the WL Club, Spanish, French and American Sign Language Honor Societies presented an International Fair to which the 6th graders were invited to come and see the wonders that the WL Department offer, along with 7-12 students, they enjoyed various activities including games, crafts, learning experiences and even an Italian Ice!

Thursday was also an exciting day with a scavenger hunt for National Flowers and those who found them won a prize!

Friday was the piece de resistance with our International Games facilitated by the World Language Department and The Physical Education Department, specifically Mr. Sinclair who was our International Sports Rockstar! Students enjoyed games from all over the world and fun was had by all, even teachers!!

English Department: The English department has begun its school-wide writing initiative, Ride the Wave of Kindness. Students in English classes will write about kindness. As part of the initiative, if students, faculty, or staff spot peers, teachers, or colleagues demonstrating kindness, they can submit the name of the individual to a digital form accessed on Teams. After the show, the students will get to chat with the cast members, and then they will all have pizza back at the school.

Mr. Conboy then reported on the following: One of the things that came to mind this week was that three years ago this week all the schools in New York State shut down, that was March 16th. We have come a long way from that time, but we all still have to be mindful of the impact that that had on our students, particularly the seniors that are graduating this year. They had a high school experience like no other. They were freshmen when the school shut down and returning to school wearing masks and the number of things that they had to endure. So, the kids that are graduating this year will be a great celebration as they graduate and move on to the next stage in their lives. It doesn't seem like three years, but that's been a tough three years worldwide. I am happy to say that Babylon has survived it well.

We also had a very special day here in the district. At the Grade School, Ms. Manza, Ms. Lunetta, and I all attended the SEL kickoff ceremony which was a really spirited and great morning. The whole student body was in the gym and sang songs and it was a great energy. Then back here at the Jr./Sr. high school, it was SEL day. They reworked and rescheduled the entire day and had guest speakers all about social emotional learning. That was a tremendous effort by the team. Just walking around, the students were well engaged in all of those activities, so kudos to all of them.

Today is our first day of Spring sports with very lousy weather, but they were all out there and they seemed to be having fun.

On our agenda tonight, unfortunately we are accepting the resignation, for retirement purposes, of Dr. Mark Malaszczyk. Not always when you get retirements it is something that you celebrate, he has been a great professional here at Babylon for a long long time, but we wish Dr. Malaszczyk well. We are busy with our budget planning, which is ongoing. Our next meeting, which is two weeks from today, we will be focusing in more about budget challenges that we have. The pandemic created some budget challenges, and other things that are going on, so we need to come up with a budget that helps us maintain what we are used to having here at Babylon. That is what we have been working on for the last several weeks. On April 10<sup>th</sup>, which is four weeks from today, we have to make sure that the budget is ready to go and be approved by the Board.

Just one more reminder regarding the emergency dismissal day, which was left off of the calendar this year. We are going to have that on the Friday, March 31<sup>st</sup>, which is the Friday before Spring break. Everybody will be dismissed 15 minutes early. We will put out a school messenger so that everybody is aware.

  WHEREAS, various educational and municipal corporations located within the State of New York desire to bid jointly for generally needed services and standardized supply and equipment items; and

WHEREAS, the Babylon Union Free School District, an educational/municipal corporation (hereinafter the "Participant") is desirous of selectively participating with other educational and/or municipal corporations in the State of New York in joint bidding in the areas mentioned above pursuant to General Municipal Law § 119-0 and Education Law Section 1950; and WHEREAS, the Participant is a municipality within the meaning of General Municipal Law § 119-n and is eligible to participate in the Board of Cooperative Educational Services, First Supervisory District of Suffolk County (hereinafter Eastern Suffolk BOCES) Joint Municipal Cooperative Bidding Program (hereinafter the "Program") in the areas mentioned above; and WHEREAS, the Participant acknowledges receipt of the Program description inclusive of Eastern Suffolk BOCES' standard bid packet and the general conditions relating to said Program; and

WHEREAS, with respect to all activities conducted by the Program, the Participant wishes to delegate to Eastern Suffolk BOCES the responsibility for drafting of bid specifications, advertising for bids, accepting and opening bids, evaluating bids, awarding via Eastern Suffolk BOCES Board approval, and reporting the results to the Participant.

**BE IT RESOLVED** that the Participant hereby appoints Eastern Suffolk BOCES to represent it and to act as the lead agent in all matters related to the Program as described above; and **BE IT FURTHER RESOLVED** that the Participant hereby authorizes Eastern Suffolk BOCES to place all legal advertisements for any required cooperative bidding in Newsday, which is designated as the official newspaper for the Program; and

**BE IT FURTHER RESOLVED** that a Participant Meeting shall be held annually consisting of a representative from each Program Participant. Notice of the meeting shall be given to each representative at least five (5) days prior to such meeting; and

**BE IT FURTHER RESOLVED** that an Advisory Committee will be formed consisting of five to ten representatives of Program Participants for a term of three (3) years as authorized by General Municipal Law §119-o.2.j.

**BE IT FURTHER RESOLVED** that this Agreement with the Participant shall be for a term of one (1) year as authorized by General Municipal Law §119-o.2.j.

**BE IT FURTHER RESOLVED** that the Participant agrees to pay Eastern Suffolk BOCES an annual fee as determined annually by Eastern Suffolk BOCES to act as the lead agent for the Program.

T. Patiri reported that they had a Policy Committee meeting today and discussed policies that NYSSBA reviewed. They are reviewing the notes received from NYSSBA and hope to have a first reading of these policies at our next meeting.
