Student delegates, Ronnie Pashen and Max O'Handley, reported that homecoming will be held on October 19th, the Breast Cancer Walk will be held on October 24th and the first Annual Safe Halloween will be held on October 31st. On September 21st over 40 BHS students volunteered at Gilgo Beach to celebrate International Coastal Clean-up Day. They also reported on other activities in the high school. Mr. Rozakis, Superintendent, reported that October is Emergency Preparedness Month in the Babylon Schools. In the coming weeks, our students will undergo practice drills in sheltering-in and locking-down. Mr. Cirone was presented with a certificate from NYSED declaring Babylon Junior-Senior High School a Reward School. The building principals reported on highlights in each of their buildings.
